Union Market Neighbors (UMN) is an nonprofit citizens association in DC. Upon advice from attorneys UMN submits Form 153 to ask the Commission live up to the request of the Court in helping mediate this case, as the Commission is the Respondent in the appeal. Following on from the instruction of Form 153, UMN cites DCMR 11-2400.2, .3, .4, and .8 among others, as well as 11-DCMR 101.2 and DC Code 6-641.02, and .02 we ask the Commission accept this request for reconsideration and reopening the record to consider fundamental and basic planning issues otherwise eschewed at this point, being and representing serious and concrete injury to UMN members living in the area around the PUD site. The whole neighborhood approach was delegated to profits and efficiency in the processing of this PUD against the law. What is required is a comprehensive public review of potential impacts to those living in the area around the PUD site. This has not happened, especially in cumulation with the great many other projects around the site. These impacts include that of nosie, refuse, socio-economic, health, and degradation of existing levels of public services serving the area and those UMN members in the area such as transit ways, infrastructure, community facilities (schools, libraries, police/fire, recreation, etd) and land value destabilization and displacement. INFORMATION

- b). A request to reopen a closed record to accept a document.

A request to accept an untimely filing will be entertained by the ZC or BZA at a meeting or as a preliminary matter at a hearing. At that time, a decision will be rendered. Please note, in the case of a request to reopen the record, pursuant to 11 DCMR Subtitle Z § 602.6 and Subtitle Y § 602.6, the request will be presented to the Chairperson for consideration. The request must demonstrate good cause and the lack of prejudice to any party. If granted, the materials shall be entered into the record.

INSTRUCTIONS

Any Request, as provided by the District of Columbia Zoning Regulations (11 DCMR), that is not completed in accordance with the following instructions shall not be accepted:

- Forms must be completely filled out. All information shall be furnished by the maker of the Request. If additional space is necessary, use separate sheets of 8 ½" x 11" paper to complete the form (drawings and plans may be no larger than 11" x 17").
