Pre-Hearing Submission**

Dear Chairperson Hood and Members of the Commission:

Georgetown University (“**Georgetown**” or the “**University**”) hereby submits this supplemental pre-hearing submission regarding the above-referenced application (“**Application**”) for amendments to and further processing of the 2017-2036 Georgetown University Campus Plan (the “**Campus Plan**”).

Updates to the Application

Since the filing of the Application, the University has continued to work with neighbors and other stakeholders to address the proposed amendments to the Campus Plan. In response to questions regarding events at the Car Barn, the University has agreed to the following additional condition:

Outdoor events held at the Car Barn fourth floor patio and covered pavilion shall end by 8:00 PM and shall not be permitted on weekends and holidays, unless agreed to by the GCP.

This condition would be added to existing Condition 23 (which addresses events at athletic fields and the performing arts center) as Condition 23(c). All other proposed conditions remain as previously proposed by the University in the initial application.
