Attached is a completed Form 130 – ANC Setdown Form.

Here is the language in the material substance section:

At its regular meeting on June 8, 2017, the Advisory Neighborhood Commission 7C ("ANC7C" or "Commission") considered the above-referenced matter. With all 7 Commissioners in attendance, a quorum at a duly-noticed public meeting, the Commission approved the following resolution by a vote of (7-0). ANC7C supports the development of the Strand Theatre, contingent upon the Warrenton Group informing all community members of the PUD project. However, the Warrenton Group has not completed the outreach process with all ANC7C Civic/Citizens Association groups; therefore, ANC7C does not approve that Case 17-10 should have a set down for a Zoning Hearing. This process should be postponed until the Warrenton Group provides a PUD presentation and discuss Community Benefits with all ANC7C Civic/Citizens Associations.
