Dear Neighbors,

We have come to the point in our struggle against the proposed Erkiletian/Shakespeare development at 501 I St. SW when we need to apply formally to the Zoning Commission for "party status" in the case. If we succeed in gaining party status, it will give us a guaranteed voice and other rights when the Zoning Commission hears the case (at a date still to be determined).

As most of you are aware, we have already informally constituted ourselves as United Neighbors of Southwest (UNSW) to appear before our Advisory Neighborhood Commission, to submit petitions, letters, and other information to the Zoning Commission, to lobby our city councilman, and to raise funds to retain legal counsel and experts.

We have been advised that acting as a group to obtain party status as UNSW – rather than applying as individuals or smaller groups – would be viewed favorably by the Zoning Commission and would enable us to present a more coordinated and convincing case, thus improving our chances of success.
