Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, September 29, 2015 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N W , Suite 220 South, Washington, D C , 20001, concerning the following application

Application of St. Paul's Episcopal Church, pursuant to 11 DCMR § 3104.1, for special exceptions from the child development center requirements under § 205, and the private school requirements under § 206, to allow the continued operation of a child development center and private school serving 120 children ages 2 5 through 12 years, including 18 regular staff members, in the R-3 and R-5-A Districts at premises 201 Allison Street N W (Parcel 111, Lot 37)

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

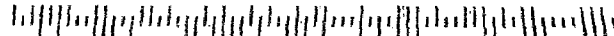

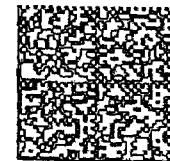

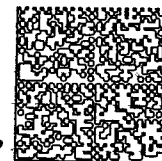
