Folger Shakespeare Library – Historic Preservation Consultation

Working with Vision Planning and Consulting between 2017 and 2018, conducted a Phase II Study, Disaster Planning for Historic Properties Initiative, for four counties across the Commonwealth of Pennsylvania for the Pennsylvania Historic and Museum Commission (PHMC). The Study focused on assessing flood vulnerability of previously identified and surveyed historic resources in Bedford, Cameron, and Monroe Counties, and the City of Philadelphia. Department of Energy, Germantown, MD – Historic Structure Report

2018-2019

As part of a team prepared a Historic Structure Report (HSR) for the Department of Energy Campus in Germantown, MD. The campus, which contains five contributing buildings and extensive landscaping, was developed in 1957-1958 to serve as the Atomic Energy Commission headquarters and was listed in the National Register of Historic Places. The HSR documents the history, integrity, and significance of the site and provides a framework for future maintenance and repair. Work involved archival research at the National Archives, National Capital Planning Commission, and Department of Energy. EHT Traceries also conducted an extensive survey and conditions assessment of the building exterior and interior, which was compared with historic documentation in order to develop a detailed inventory and analysis of extant historic features. The HSR will develop a framework for the continued management and stewardship of this resource.

Solera Reserve, Kensington, MD – Consultation and Historic Structure Reports

2018-2019

Prepared two Historic Structure Reports (HSRs) – one for the Mizell Building (located at 10500 St. Paul Street in Kensington, Maryland) and one for the adjacent gas station building (located at 10520 St. Paul Street in Kensington, Maryland) – to provide documentation to assist the Montgomery County Historic Preservation Commission in its review of the proposed rehabilitation of the buildings. The Mizell Building was constructed in c. 1902 as a general store, and 10520 was likely constructed in c. 1924 purpose-built as a gas station and garage. Both buildings are considered contributing to the Kensington Historic District. The HSRs document the renovations undertaken throughout the twentieth century to identify and provide recommendations for key character-defining features. Additionally, these reports evaluate existing conditions and make recommendations for their treatment.

Ford's Theatre Society – 512 Tenth Street, NW - Historic Preservation Consultation 2017 – 2019

As project manager, provided historic preservation consultation to assist the Ford's Theater Society with OTJ Architects with a project involving the existing building at 512 10th Street NW, a contributing resource to the Pennsylvania Avenue National Historic Site. Originally constructed in 1920 as a substation for the Potomac Electric Power Co. (PEPCO) the building was later renovated and adapted in the 1960s as an office for the utility company. The project, which includes renovation of the building with a rooftop addition to provide studio space for the Ford's Theater Society, required review and approval by the DC HPRB. Tasks included review of drawings, providing recommendations for compatibility with the historic building and the surrounding context, directing and participating in outreach with the local ANC and the DC Preservation League, and consultation with HPO Staff.
