Below is a screeenshot one person sent me who had been trying since this morning to submit testimony. I tried myself at 1:48pm, in order to verify the problem persists and received the same message.

Prematurely cutting off the right of the public to submit testimony in this case is serious. When did the Commission cutoff the right of the public to submit written testimony in this case? How could such a problem happen?
