At a regularly scheduled and properly noticed public meeting held on September 24, 2024, with a quorum of 6 of 9 commissioners being present, Advisory Neighborhood Commission ("ANC") 6E voted, with 6 ayes, 0 nays, and 0 abstentions, to support Georgetown University's application to modify and supplement the relief granted in its Mandatory Design Review approval of its New Law Building (ZC Order 23-10), which is located on Lot 865 and a portion of Lot 864 in Square 569 as follows:

WHEREAS, the Duties and Responsibilities of the Advisory Neighborhood Commission Act of 1975 grants ANC 6E the responsibility to advise the Council of the District of Columbia, the Mayor, and each executive agency and all independent agencies, boards, and commissions of the government of the District of Columbia with respect to all matters of District government policy, including decisions regarding planning, streets, recreation, social services programs, education, health, safety, and sanitation which affect the ANC 6E area;

WHEREAS, the Georgetown University law school is located within the jurisdictional boundaries of ANC 6E in single member district 6E08;

WHEREAS, Greg Klass and Cory Peterson, representing Georgetown University, came before the ANC on September 24, 2024, to present a revised plan for bicycle parking on the campus in ANC 6E, and a proposal for signage on the New Law Building;

WHEREAS, the ANC had no objections to the proposed sign atop the New Law Building;

WHEREAS, the revised bicycle parking plan includes a holistic approach to bicycle parking needs that will distribute parking spaces around two green spaces and near the new Law Building, incorporates DDOT-recommended inverted U racks, and attending commissioners expressed support for the concept;

THEREFORE, BE IT RESOLVED, that ANC 6E supports the addition of building identification signage on the upper stories of the northwest corner of the New Law Building, facing 2nd Street NW.

AND BE IT FURTHER RESOLVED, that ANC 6E supports relief from the short-term bicycle parking requirements, which would require 68 spaces within a short distance of the New Law Building's front door. The Commission endorses the University's proposed plan, which treats short-term bicycle parking on a holistic basis across the Law Center and provides a total of 154 spaces, including 64 spaces on the Eleanor Holmes Norton Green and 90 spaces on the Dean Green.
