October 16, 2024: ANC 5B recieved its official presentation from the Project Team and the 200'ers addressed the ANC as well.

November 12, 2024: Brookland Neighborhood Civic Association (BNCA) meeting 7pm. where the project team and 200 footers presented to the community and the FAQ was established that we worked from that point on.

April 10, 2025: 5B Development Zoning and Land Use (DZLU) committee was formed.

April 14, 2025: DDOT via phone confirmed the information given to the project team and referred Comm. Amin to the DDOT regulations and guidelines and Ms. Williams also agreed to virtually meet with Comm. Amin and community members.

April 15, 2025: BNCA and 200'ers held a listening session (in-person) with the Project Team at Brooks Mansion.
