Hi Oliver & Melissa,

I'm looking for some help getting DGS to properly maintain the unoccupied DC shelter property at 1861 Corcoran St NE - This is a family shelter that has been unoccupied for 2 years and is not being properly managed by the district.

There are 3 issues:

- 1) The hose spigot on the street needs to be turned off from inside the building. It is being used as a public shower by unhoused people, and there are consistently naked people showering in public on the street or doing laundry on the sidewalk.
- 2) The back yard has not been mowed in several years. There are full size trees growing out of the back now and onto adjacent properties.
- 3) There are broken windows on the 2nd floor, left behind from when the building was being used as a crack den after the property was broken into last year. Nobody has come to repair.

Any help is appreciated. I have tried contacting DGS myself and have gotten nowhere.
