Dear Chairman Hood and Directors Bardin and Cozart;

I am writing on behalf of Chevy Chase ANC 3/4G to thank you for withdrawing Zoning Case 25-11 and for rescheduling Zoning Commission hearings on Cases 25-08 and 25-06 until January 2026. I also am writing at the direction of the ANC to request that you, a) push off by, at minimum, several weeks your rescheduled series of hearings on

Case 25-12, the so-called "Omnibus" text amendment, and b) direct Joel Lawson, the Office of Planning's associate director and, as we understand it, the case manager for the "Omnibus" to brief our ANC about the measure and take questions at a special public meeting that we would schedule at the earliest date he is available.

We recognize OP has been working on the Omnibus for a substantial period but given its 24 distinct provisions and the possible interactions of these provisions with elements of 25-08 and 25-06, we simply have not been able to get our arms around the measure and therefore cannot provide useful feedback. We believe many other ANCs in DC are in a similar situation.

I was authorized to write to you about these matters by an ANC vote of 6-0-0 at a duly noticed meeting of our commission tonight. We look forward to your early response.
