**CASE NO. 25-10 (Alturas, LLC – Text Amendment to Subtitle U § 514.3 to Exempt the Property at 1781 Florida Avenue, N.W. from Certain Prohibited Uses in the Reed-Cooke Overlay)**

On May 12, 2025, Alturas, LLC (the “Petitioner”) filed a petition proposing the following amendment to the Zoning Regulations (Title 11 of the D.C. Municipal Regulations, Zoning Regulations of 2016, to which all references herein refer unless otherwise specified):

Subtitle U, Use Permissions

§ 514 – Prohibited Uses (MU-USE Group E)

§ 514.3 – To exempt Square 2557, Lot 800 from otherwise prohibited uses for off-premises alcoholic beverage sales, parcel delivery service establishment<sup>1</sup>, restaurant, and veterinary hospital.

The proposed text amendment would allow the property at 1781 Florida Avenue, N.W. (Square 2557, Lot 800) to have an off-premises alcoholic beverage sales, parcel delivery service establishment, restaurant or veterinary hospital use as a matter-of-right in the MU-4/RC zone.

<sup>1</sup> The Petitioner’s prehearing statement, filed on September 4, 2025, proposed a revision to the originally proposed text adding a parcel delivery service establishment as an otherwise prohibited use from which Square 2557, Lot 800 would be exempt. (Ex. 11.) The Petitioner’s prehearing statement indicated that it notified the Office of Planning (OP) of the proposed revision and OP stated no objection to the revision. (*Id.*)

The Office of Planning (OP) filed a set down report dated July 21, 2025 recommending that the Commission set down the petition for a public hearing. The OP set down report concluded that the proposal would not be inconsistent with the Comprehensive Plan maps and written elements, including when viewed through a racial equity lens. At a public meeting on July 31, 2025, the Commission voted to set down the petition for a public hearing. The Petitioner filed its prehearing statement on September 4, 2025.

This public hearing will be conducted in accordance with the rulemaking provisions in Subtitle Z, Chapter 5 of the Zoning Regulations.

### **Proposed Text Amendment**

The proposed amendments to the text of the Zoning Regulations are as follows (text to be deleted is marked in ~~bold and strikethrough~~ text; new text is shown in **bold and underline** text):

**Subsection 514.3 of § 514 – PROHIBITED USES (MU-USE GROUP E) of Subtitle U, USE PERMISSIONS is proposed to be amended to read as follows:**

- 514.3        In the MU-4/RC and MU-5A/RC zones, the following uses shall be prohibited:
- ...
- (r)        Off-premises alcoholic beverage sales, except that the off-premises beer and wine sales accessory use in the grocery store located in Square 2572, Lot 36, may continue as a matter of right provided that it shall not occupy more than 2,078 square feet of the store's gross floor area, **and that the off-premises beer and wine sales may be permitted as a matter of right primary or accessory use in Square 2557, Lot 800;**
- ...
- (t)        Parcel delivery service establishment other than one exclusively dedicated to serving a sound stage or a movie, video, or television production facility that existed on April 26, 1991, **except that a parcel delivery service establishment may be permitted as a matter of right in Square 2557, Lot 800;**
- (u)        Restaurant or fast food establishment, **except that a restaurant may be permitted as a matter of right in Square 2557, Lot 800;**
- (x)        Veterinary hospital, **except that a veterinary hospital may be permitted as a matter of right in Square 2557, Lot 800;** and
- ...
