We wanted to follow up now that the rezoning application from Andy and Debbie Wilson LLC has been officially filed with the city on July 2, with the ANC notified on July 10. The case was officially filed as case 26-08. We know you've each been tracking this closely, and we appreciate the attention you've given it so far.

As you're aware, our community continues to have significant concerns about this rezoning, and that sentiment has only grown — nearly every home on our block has now signed on to our letter of opposition.

Given our earlier conversations that the ANC's formal role would begin once the developer filed with the city, we think now would be a good time to reconnect. **We'd welcome the chance to sit down in**

person with Commissioners Kelley, Morales, Sherman, and Thomas-Davis sometime in the next 2-3 weeks to walk through where things stand and talk through next steps together.

Ms. Morgan and Neighbors,

Thank you again for your letter regarding 1327 Girard St. NW, and my sincerest apologies for missing your 20-day deadline.

As of today, there is still no BZA case before the ANC, and therefore, there is nothing for the ANC to respond to or weigh in on.

However, I can share that I will not support a proposal for a 9-story building at 1327 Girard. I aim to strike a compromise between the 9-story building proposed by the developer and the 3-4 story building proposed in your letter.

I also want to state my intent to address the concerns listed in your letter about inadequate city services, the state of the 14th and Girard St. park, insufficient parking and the pervasive rodent issue in our neighborhood. Though I plan to advocate for solutions within this BZA process, I also plan to put forth a resolution to designate city funds toward the improvement of the 14th and Girard St park in the next couple of months. With several ANC colleagues, I will continue advocacy for a city-wide comprehensive rodent abatement strategy and push for any containerization pilot programs to take place in Columbia Heights. Finally, I am exploring options to expand areas for residential parking permit holders to store their vehicles, taking many vehicles off of already crowded streets, including Girard Street NW.

Thank you all for your continued advocacy, commitment to our neighborhood, and investment in this matter.

On behalf of 48 residents of Ward 1 and ANC 1A09, please find attached a community letter of opposition to the rezoning of 1337, 1339, and 1327 Girard St NW. Andy and Debbie Wilson LLC has stated their intent to rezone these properties from an RF-1 zone to an RA-4 zone in order to develop a 9-story building on a single parcel of land in the middle of our block located at 1327 Girard St NW, which is currently situated between multiple 3-story townhomes. They initially shared this intent in a letter to our community dated July 2025. They recently shared an update that they intend to formally file the zoning application around June of 2026.

We feel strongly that this proposed rezoning and their proposed development is inappropriate for our neighborhood for the reasons outlined in the attached letter, but would also set a precedent for inappropriate rezoning of a wider block in order to develop a high-rise development on a single parcel of land situated between townhomes. We also have significant concerns that the rezoning of 1337 and 1339 Girard St. NW, which are currently multi-unit townhomes filled with renters, would put those neighbors at risk of displacement.

In summary, we respectfully request that ANC 1A take the following actions based on the overwhelming opposition of the ANC1A09 residents who would be most directly impacted by this rezoning:

1. **Cease the encouragement of the rezoning of this property in the ANC Committee on Housing and Zoning** and ensure neighboring residents are represented in any ANC conversations with the developer.
2. **Pass a resolution in opposition to this rezoning application** once the developer formally submits an application to the DC Zoning Commission.
3. **Protect the livability and historic character** of our residential neighborhood.
4. **Demand city commitment** to address existing service failures.

Our community will participate in two meetings this evening where we intend to further share our perspectives. **We invite you all to join so the wider ANC, our city council representatives, and relevant DC government offices have a chance to hear more fully from our community as well.**

We wanted to follow up now that the rezoning application from Andy and Debbie Wilson LLC has been officially filed with the city on July 2, with the ANC notified on July 10. The case was officially filed as case 26-08. We know you've each been tracking this closely, and we appreciate the attention you've given it so far.

As you're aware, our community continues to have significant concerns about this rezoning, and that sentiment has only grown — nearly every home on our block has now signed on to our letter of opposition.

Thank you again for your letter regarding 1327 Girard St. NW, and my sincerest apologies for missing your 20-day deadline.

As of today, there is still no BZA case before the ANC, and therefore, there is nothing for the ANC to respond to or weigh in on.

However, I can share that I will not support a proposal for a 9-story building at 1327 Girard. I aim to strike a compromise between the 9-story building proposed by the developer and the 3-4 story building proposed in your letter.

I also want to state my intent to address the concerns listed in your letter about inadequate city services, the state of the 14th and Girard St. park, insufficient parking and the pervasive rodent issue in our neighborhood. Though I plan to advocate for solutions within this BZA process, I also plan to put forth a resolution to designate city funds toward the improvement of the 14th and Girard St park in the next couple of months. With several ANC colleagues, I will continue advocacy for a city-wide comprehensive rodent abatement strategy and push for any containerization pilot programs to take place in Columbia Heights. Finally, I am exploring options to expand areas for residential parking permit holders to store their vehicles, taking many vehicles off of already crowded streets, including Girard Street NW.

Thank you all for your continued advocacy, commitment to our neighborhood, and investment in this matter.

On behalf of 48 residents of Ward 1 and ANC 1A09, please find attached a community letter of opposition to the rezoning of 1337, 1339, and 1327 Girard St NW. Andy and Debbie Wilson LLC has stated their intent to rezone these properties from an RF-1 zone to an RA-4 zone in order to develop a 9-story building on a single parcel of land in the middle of our block located at 1327 Girard St NW, which is currently situated between multiple 3-story townhomes. They initially shared this intent in a letter to our community dated July 2025. They recently shared an update that they intend to formally file the zoning application around June of 2026.

We feel strongly that this proposed rezoning and their proposed development is inappropriate for our neighborhood for the reasons outlined in the attached letter, but would also set a precedent for inappropriate rezoning of a wider block in order to develop a high-rise development on a single parcel of land situated between townhomes. We also have significant concerns that the rezoning of 1337 and 1339 Girard St. NW, which are currently multi-unit townhomes filled with renters, would put those neighbors at risk of displacement.

In summary, we respectfully request that ANC 1A take the following actions based on the overwhelming opposition of the ANC1A09 residents who would be most directly impacted by this rezoning:

1. **Cease the encouragement of the rezoning of this property in the ANC Committee on Housing and Zoning** and ensure neighboring residents are represented in any ANC

conversations with the developer.

2. **Pass a resolution in opposition to this rezoning application** once the developer formally submits an application to the DC Zoning Commission.
3. **Protect the livability and historic character** of our residential neighborhood.
4. **Demand city commitment** to address existing service failures.

Our community will participate in two meetings this evening where we intend to further share our perspectives. **We invite you all to join so the wider ANC, our city council representatives, and relevant DC government offices have a chance to hear more fully from our community as well.**
