On October 1, 1987, at a special meeting, the Zoning Commission for the District of Columbia initiated action to sponsor consideration of amendment of the zone district classification of parts of lots 1 and 804 in Square 2039, from R-1-A to R-5-C, and authorized the scheduling of a public hearing on the above-numbered case. The public hearing has been scheduled to be held on January 14, 1988, provided that compliance with certain procedures is met. Enclosed is a copy of a referral to the Office of Planning (OP), which includes a list of the properties that are affected by the OP proposal.

The Commission has also scheduled a prehearing conference in this case for December 10, 1987, at 7:00 P.M., in Room 9, District Building, 1350 Pennsylvania Avenue, N.W.
