Friends of Tregaron is an organization representing some 400 families in the Cleveland Park area and throughout the city, who are concerned with the preservation and appropriate development of the Tregaron Estate, a designated historic landmark within the boundaries of the Cleveland Park Historic District. Because our organization has long been concerned about the need to integrate historic preservation values into the zoning process, and because we feel the proposal of the Office of Planning for a special Cleveland Park Historic Overlay District offers just such a solution, Friends of Tregaron wishes to go on record as supporting the petitioners' request for creation of this overlay zone in Case No. 86-26 to be heard before your Commission on January 25, 1988.
