# Memorandum

SUBJECT: Responsibilities of ANCs

The following are excerpts from DCMR Section 3011.7 (Sections 3.1d and 3.1e, Z.C. Rules of Practice and Procedure):

- 3011.7 If an Advisory Neighborhood Commission (ANC) wishes to participate in a matter being considered as a contested case proceeding under §§3022 through 3023 [Chapter 6, Rules of Practice and Procedure], the ANC shall file a written report with the Zoning Commission at least seven (7) days in advance of the hearing. In a matter being considered as a rulemaking proceeding under §3021 [Chapter 5, Rules of Practice and Procedure], there shall be no filing deadline as long as the record in that case is open. All written reports shall contain the following:
- (a) An identification of the application;
  - (b) When the public meeting of the ANC to consider the application was held;
  - (c) Whether proper notice of that meeting was given by the ANC;
  - (d) The number of members of the ANC that constitute a quorum and the number of members present at the meeting;
  - (e) The issues and concerns of the ANC about the application, as related to the standards against which the application must be judged;
  - (f) The recommendation, if any, of the ANC as to the disposition of the application;
  - (g) The vote on the motion to adopt the report to the Commission;
  - (h) The name of the person who is authorized by the ANC to present the report;
  - (i) The signature of the Chairman or Vice-Chairman of the ANC.
- 3011.8 The Commission shall give "great weight" to the written report of the ANC, as required by Section 1-261, D.C. Code, 1981 Ed. In the event the ANC submits its report on the basis of understandings, agreements or meetings with the applicant which later are modified by the applicant, the designated representative of the ANC may comment orally concerning the specific modifications. No other new matters may be presented orally by the designated representative of the ANC. The Commission may leave the record open to permit the ANC to submit a revised report.
