Support for Re-zoning in Cleveland Park

I urge your commission's support of the Cleveland Park Historical Society, et.al., petition to re-zone the Cleveland Park area in question -- to preserve the residential nature of Cleveland Park and to prohibit massive development that would drive the lower and middle income property owners out of the area and out of the District of Columbia. I note the following points for your consideration:

- I. I purchased my home in Cleveland Park because I like the neighborhood atmosphere within the city limits; I like the low density, I like the small business establishments and services, and I like the safety of the neighborhood;
- 2. I support, and appreciate, the efforts of those in Cleveland Park who prefer to preserve and restore and rehabilitate, rather than proceed with massive demolition and new development;
- 3. Parking in Cleveland Park is woefully inadequate, now;
- 4. Public studies have shown that, at the end of the subway line in Prince Georges County where a massive office building was built, that 8% of the workers use the sybway, whereas 92% of the workers drive to work;
- 5. As you know, Ward 3 Council Member Jim Nathanson and others visited the city of Atlanta to look at a new subway system vs. development, and discovered that, in fact, one subway stop (which had an historic designation similar to Cleveland Park's) has remained a low density neighborhood without affecting the viability of the subway system. (Another note: as a subway communter, I can tell you that during rush hour, the Cleveland Park subway stop cannot handle an influx of new commuters, even if they were to occur);
- 6. The Cleveland Park Historical Society, and others, have made alternative suggestions and proposals of moderate development and rehabilitation for Cleveland Park that would enhance the economic base ase well as the appearance of Cleveland Park, yet would preserve the neighborhood; and
