## ZONING COMMISSION FOR THE DISTRICT OF COLUMBIA NOTICE OF FINAL RULEMAKING CASE NO. 86-26 (Map Amendment - Connecticut Avenue) Sqs. 1872, 1875, 1876 & 2204

The Zoning Commission for the District of Columbia, pursuant to the authority set forth in Section 1 of the Zoning Act (D.C. Code, Section 5-413), hereby gives notice of the adoption of an amendment to the District of Columbia Zoning Map. The amendment derives from the Connecticut Avenue Text and Map Amendments case, and is intended to make zoning not inconsistent with the Comprehensive Plan for the National Capital, pursuant to the requirements of the Plan. Notice of proposed rulemaking was published in the D.C. Register on July 1, 1988 (35 DCR 5143). The amendment was adopted by the Zoning Commission as a final action at its regular monthly meeting held on August 8, 1988. The specific amendment to the Zoning Map is as follows:

- 1. Change from R-5-C to R-3 those portions of Squares 1872, 1875, and 1876 which are currently zoned R-5-C.
  - Squares 1872, 1875, and 1876 are bounded by Connecticut Avenue, Harrison Street, 38th Street, and Military Road, N.W.
- Change from C-2-B to R-4, Lots 137 and 138 in Square 2204.
  - Square 2204 is bounded by Calvert Street, Connecticut Avenue, Woodley Road, and Woodley Place, N.W.
