to amend the definition of a youth residential care home (Section 100.2 of Subtitle B of the Zoning Regulations).

**Existing Language (include section or paragraph number):**

Subsection 100.2 of § 100, DEFINITIONS, of Chapter 1, DEFINITIONS currently reads: Youth Residential Care Home: A facility providing safe, hygienic, sheltered living arrangements for one (1) or more individuals less than eighteen (18) years of age, not related by blood, adoption, or marriage to the operator of the facility, who are ambulatory and able to perform the activities of daily living with minimal assistance.

**Proposed Language:**

Subsection 100.2 of § 100, DEFINITIONS, of Chapter 1, DEFINITIONS of is proposed to be amended by revising the definition of Youth Residential Care Home to read as follows: Youth Residential Care Home: A facility providing safe, hygienic, sheltered living arrangements for one (1) or more children not related by blood, adoption, or marriage to the operator of the facility, who are ambulatory and able to perform the activities of daily living with minimal assistance. For purposes of this definition, a child means any individual who is: a. under 18 years old; or b. 18 to 20 years of age and subject to a dispositional order pursuant to Chapter 23 of Title 16 of the D.C. Code.
