On behalf of Howard University ("Howard" or "University"), we will be submitting two paper copies of this application and the proposed 2020 Central Campus Plan for Howard University ("2020 Plan"). The paper copies will be submitted as appropriate when the current COVID-19 closure of government offices is lifted. The Application is being filed electronically through the Interactive Zoning Information System (IZIS) in compliance with the filing requirements set forth in Subtitle Z, Chapter 3 of the Zoning Regulations, and includes the following:

- (i) A completed application form;
- (ii) A letter from the University authorizing the filing of the application;
- (iii) Certified surveyor's plats of key properties and a map showing all of the University lots and squares located with the campus boundaries;

- (v) A list of property owners with 200 feet of the property; and
- (vi) A certificate of compliance with the filing requirements of Subtitle X and Subtitle Z of the Zoning Regulations and the conditions set forth in ZC Order Nos. 11-15 and 11-15F.

Two sets of preprinted labels for the surrounding property owners and parties, and a check for \$6,500 made payable to D.C. Treasurer, which represents the filing fee in this matter will also be delivered to you at the appropriate time.
