An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>May 17, 2018</u> through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on <u>Wednesday, July</u> <u>25, 2018 at 9:30 am</u>, at the Jerrily R. (Square 526, Lots 20, 21, 804, 805, 824, 825, and 829).
