Appeal of Advisory Neighborhood Commission 6C

BZA Appeal No. 19550

On September 19, 2018, the Board of Zoning Adjustment (Board) required DCRA to:

- 1) Create a timeline of the permits issued to 1125 7<sup>th</sup> Street, N.E.;
- 2) Identify changes which occurred between each revision;
- 3) Identify when each permit was issued, submitted and completed; and
- 4) Identify cases where the Zoning Administrator has protected a cornice from removal within the most recent three years.
