A Foreign Mission is requesting permission to locate, replace, or expand a chancery use in a location where a chancery use is not permitted as a matter of right for the zoning district. The Office of Zoning ("OZ") requests that the Office of Planning provide a report on this application, as the Board's determination of this application must be solely bases upon the following six factors:

- (a) The international obligation of the United States to facilitate the provision of adequate and secure facilities for foreign missions in the Nation's Capital;
- (b) Historic preservation, as determined by the Board after receipt of report and recommendation from the Historic Preservation Review Board:
- (c) The adequacy of parking and the extent to which the area will be served by public transportation to reduce parking needs, subject to such special security requirements as may be determined by the Secretary of State, after consultation with federal agencies authorized to perform protective services;
- (d) The extent to which the area is capable of being adequately protected, as determined by the Secretary of State, after consultation with federal agencies authorized to perform protective services;
- (e) The municipal interest, as determined by the Mayor of the District of Columbia; and
- (f) The federal interest, as determined by the Secretary of State.

Since factors (d) and (f) are to be determined by the Secretary of State, your report need not address these criteria. As to factor (e), which is the determination of the municipal interest by the Mayor, OZ understands that this function has been delegated to OP and therefore this

If such is the case, please refer the application to the Historic Preservation Review Board, and/or the Commission of Fine Arts if required by D.C. Law 2-144, for report and recommendation to the Board of Zoning Adjustment. Such a report and recommendation may be appended to your report.
