STATEMENT OF POINTS AND AUTHORITIES IN SUPPORT OF MOTION TO
CONTINUE HEARING DATE BEFORE THE BOARD OF ZONING ADJUSTMENT

The Applicant, Team Washington, Inc. d/b/a Domino's Pizza, moves for a continuance of the hearing date before the Board of Zoning Adjustment (the "BZA") in Case No. 19600. The current hearing date is scheduled for November 8, 2017. Initially, the hearing was scheduled for October 25, 2017, but was administratively rescheduled to November 8, 2017 at the request of the BZA. The Applicant now moves for a continuance of the hearing to the next available hearing date in December 2017.

The Applicant requests a continuance of the hearing date to allow additional time to work with the affected ANC (ANC3B) and the community to address comments from the ANC and the community related to the Application. The Applicant has met with ANC3B on two occasions, on September 14, 2017, and again on October 12, 2017. The ANC is currently considering the Application and potential conditions that have been proposed related to the Applicant's operations. Continuance of the hearing date to the next available hearing date available in December will allow the Applicant additional time to address comments and concerns that the community may have related to the Application. The Applicant has notified the ANC about this Motion, and the ANC has no objection to the request for the continuance.

For these reasons, the Applicant respectfully requests that the hearing before the BZA be continued to the next available date in December 2017.
