## Addition to Form 150 Motion Form

I attended the ANC 7 meeting on March 8<sup>th</sup> and was not given a vote on my project. Commissioner Malloy stated that she had not received the application from BZA.

ANC 7C has requested the hearing scheduled for March 21st be moved to after April 12th. I did not consent to this motion I wanted a vote on March 8th from the ANC. I could not force a vote.

## **Applicant Actions:**

I Contacted commissioner Malloy via phone in early January, She was in a class and instructed me to call the office and leave a message which is what I did, I never received a follow up call after several messages. In person I attended my first ANC meeting on Feb 8th 2018, thinking that surely from the phone messages, certified mail from me on Jan 3<sup>rd</sup> and certified mail from zoning this would be on someone's radar. It was not, I was allowed to make a brief presentation and instructed to appear before the board on Feb 22<sup>nd</sup>2018. In an effort to stay in touch and keep the board apprised of some of the changes that had taken place, I emailed the entire board using there .gov ANC emails listed on the website.( screen shots attached). I did not receive 1 single reply and still have not. No one showed up for the meeting on the 22nd which was slated to start at 7pm, so I began going to the homes of the commissioners, and after 3 no answers I found Chairman Holmes at home where he notified me that the meeting was cancelled due to 3 commissioners being out of town. He told me that he would put me on the schedule for March 8<sup>th</sup> and that my case could be voted on and I would just need them to forward the outcome to zoning.

On March 8<sup>th</sup> I was given a chance to present to the community. There was no verbal opposition among the community only verbal support among many who attended. Commissioner Malloy noticed that she had not received the application from zoning and told me that this is about process and that a vote would not be taken. The process of follow up and accountability is for all parties. There was no verbal opposition among the community only verbal support among many who attended. I am not sure how accountability applies to the ANC. There have been no postings in opposition I have support from OP, DOT and have shown that the variance has no adverse effects on the community. I move that the BZA meeting stand and vote in the affirmative.
