Dear Chairperson Hill and Members of the Board:

On behalf of Aubrey Stephenson, adjacent property owner and interested party herein, I respectfully request an extension of an additional week through June 8, 2018 to submit his response to Applicant's Supplemental Filings.

Indeed, the significant impact the Applicant's plans portend for Mr. Stephenson's properties has forced him to engage the services of architectural and engineering advisors. However, time constraints and competing schedules of these professionals have not allowed completion of the evaluation of the Applicant's various filings at this point, thereby necessitating the need to request this extension of time.

Although Mr. Stephenson and the Applicant initiated some discussions about an agreement to address some of Mr. Stephenson's concerns, the parties have not reached one to date. Therefore, I wish to preserve Mr. Stephenson's rights as an interested party because he remains very concerned about the non "as of right" structure planned for 925 5th Street, NW that will have a building wall only 4.5 feet from his properties and will adversely impact the overall value of his buildings.

Thank you for your consideration, and we look forward to discussing these matters with the BZA at the June 20th hearing.
