**REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING**

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on April 23, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, September 12, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of District of Columbia Public Schools**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle C § 1504 from the penthouse setback requirements of Subtitle C § 1502.1 (b) and (c), to construct rooftop mechanical equipment screening on an existing public school in the RF-1 Zone at premises 1755 Newton Street N.W. (Square 2619, Lot 654).

You will need to create a username and password if you have not done so already.
