An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on May 23, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, September 19, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Columbia Heights Partners LLC, pursuant to 11 DCMR Subtitle X, Chapter 10, for a variance from the density requirements of Subtitle E § 201.4, to permit an existing 17-unit apartment house in the RF-1 Zone at premises 4526 13th Street N.W. (Square 2817, Lot 36).

If you wish to participate in the case, you may submit a letter in support or opposition into the record, or appear as a witness to testify at the public hearing. You will need to create a username and password if you have not done so already.
