An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on June 9, 2018 through the Interactive Zoning Information System (IZIS).

Application of Cambridge Holdings LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the residential conversion requirements of Subtitle U § 320.2, to convert an existing principal dwelling unit to a three-unit apartment house in the RF-1 Zone at premises 1128 Buchanan Street N.W. (Square 2918, Lot 113).
