Tenleytown Neighbors Association (TNA) has been informed that Advisory Neighborhood Commission (ANC) 3E has delayed consideration of and voting on the WABC-Sunrise proposal until November 8. The November 8 meeting is too late to meet the requirement that the ANC submit its report 7 days prior to the BZA hearing, which in this case is Nov 14.

TNA, as a party, does not object to this delay by the ANC so long as the applicant, WABC - Sunrise Senior living, is still required to submit all materials by October 24, the required three weeks prior to the November 14 hearing. Relevant DCMR sections below.

11-U DCMR § 406.3 If an **ANC** wishes to participate in the hearing, it must file its written report with the Board at least seven (7) days in advance of the public hearing and provide the name of the person who is authorized by the ANC to represent it at the hearing.

11-U DCMR § 406.4 The oral testimony of the **ANC** representative shall not be given great weight unless accompanied within seven (7) days by written documentation approved by the respective ANC, which supports the testimony.

## Regarding timeline for Applicant:

11-U DCMR § 300.15 No later than twenty-one (21) days before the date of the hearing for the application, the applicant shall file with the Board any supplemental statements, information, briefs, reports (including reports or statements of expert and other witnesses), plans, or other supplemental material that the applicant may wish to offer into evidence at the hearing. Any map, plan, or other document, or matter readily available to the general public need only be fully referenced and the source given by the applicant in place of filing a copy.
