

Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on <u>Wednesday, October 24, 2018 at 9:30 am</u>, at the Jerrily R. Kress Memoria! Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of RUPSHA 2011 LLC, pursuant to 11 DCMR Subtitle X, Chapter 10, for area variances from the lot dimension requirements of Subtitle D § 302.1 and the side yard requirements of Subtitle D § 307.1, to construct a new detached principal dwelling unit in the R-2 Zone at premises 4417 A Street S.E. (Square 5350, Lot 38).

#### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

#### HOW TO FAMILIARIZE YOURSELF WITH THE CASE


