- **Affidavit of Posting**: An Affidavit of Posting (Form 145) must be filed at least <u>5 days</u> prior to the hearing.
- **Agent authorization**: If not already filed, a signed letter of authorization citing Subtitle Y § 300.5 must be submitted by the Applicant if represented by an agent, including a licensed architect or attorney. Visit <a href="http://dcoz.dc.gov/resources/Letter\_of\_Agent\_Authorization/index.shtm">http://dcoz.dc.gov/resources/Letter\_of\_Agent\_Authorization/index.shtm</a> if you wish to be represented by a third party.
- Changes to application: In the event that the zoning relief requested changes prior to the hearing, a revised Self-Certification (Form 135) or a revised Zoning Deficiency Letter from the Zoning Administrator must be filed, as well as any additional filing fees that may apply.

Failure to submit required documents and additional fees could delay the hearing of your case.
