An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>September 19, 2018</u> through the Interactive Zoning Information System (IZIS).

**Application of Jubilee Housing, Inc,** pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C § 703.2 from the parking requirements of Subtitle C § 701.5, and under Subtitle K § 716 from the lot occupancy requirements of Subtitle K § 703, to construct a one-story and penthouse addition and convert the existing office building to a mixed-use building in the RC-3 Zone at premises 1724 Kalorama Road N.W. (Square 2567, Lot 90).
