REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on September 22, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, December 19, 2018 at 9:30 am**, at the Jerrily R. Application of Marjorie Hutchinson, pursuant to 11 DCMR Subtitle X, Chapter 10, for a use variance from the use provisions of Subtitle U § 301, to permit the conversion of an existing nonconforming non-residential use to a restaurant in the RF-1 Zone at premises 1724 North Capitol Street N.W. (Square 3105, Lot 72).

If you wish to participate in the case, you may submit a letter in support or opposition into the record, or appear as a witness to testify at the public hearing. Visit the Interactive Zoning Information System (IZIS) on our website at <https://app.dcoz.dc.gov/Login.aspx> to make a submission. You will need to create a username and password if you have not done so already.
