At the hearing dated December 19, the record was closed and the applicants were			
asked to coordinate with neighbors. No effort was made to do so until January 15 when exhibit 52 was distributed.			
On January 17, with two days notice over a holiday weekend, a meeting was scheduled			
for January 19. Although a tentative compromise agreement was discussed at that meeting			
the written details were not finalized and it became clear that a consensus could not be			
reached among neighbors after the publication of the Office of Planning report on January 23.			
On January 27, exhibit 55 was added to the record, purporting to outline an unsigned			
agreement between neighbors and the applicant.			
I request that the board consider reopening the record to ensure that information related			
to the context of this coordination with neighbors is considered.
