Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, December 19, 2018 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 2020 M Street LLC and 2030 M Street LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C §§ 1304.2 and 1312 from the roof-mounted antenna setback and height requirements of Subtitle C § 1304.1(a) and (b), to locate three antennas on the roof of a to-be-constructed 11-story office building in the D-5 Zone at premises 2050 M Street N.W. (Square 100, Lot 122).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
