An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on November 14, 2018 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, February 27, 2019 at 9:30 am**, at the Jerrily R. **Application of Catholic Charities of the Archdiocese of Washington, Inc.**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle U § 203.1(p), to construct a solar array in the R-1-B Zone at premises 2800 Otis Street N.E. (Square PAR 167, Lots 67 and 68).

You will need to create a username and password if you have not done so already.
