#### REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

**Application of Sarah Beth and Josh Kuyers**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle E § 5201 from the rear yard requirements of Subtitle E § 506.1, and pursuant to Subtitle X, Chapter 10, for an area variance from the lot occupancy requirements of Subtitle E § 504.1, to construct a one-story rear addition to an existing, attached principal dwelling unit in the RF-3 Zone at premises 156 Duddington Place S.E. (Square 736, Lot 68).
