- 2. ANC reports and any accompanying documents must be submitted to the record by using:

- 3. Submission deadlines are as follows:
 - a. ANCs must file this form at least seven (7) calendar days in advance of the hearing, if they wish to participate in a public hearing under Subtitle Z § 406.3 and Subtitle Y § 406.3.
 - b. In all cases before the ZC or BZA, ANCs must file this form before the ZC or BZA makes a decision in order to receive great weight.

Re: BZA Case No. 20006 - T-Mobile at Nationals Youth Park

Chairperson Hill,

At its regularly scheduled and properly noticed meeting on May 21, 2019, our Commission voted 4-2, with an established quorum, to support the Applicant's request for a Special Exception to allow for the installation of an 81'6" replacement light pole that will house T-Mobile's telecommunications equipment and an ancillary 10' x 20' equipment compound at 3675 Ely place, S.E. – the Washington Nationals Youth Baseball Academy.

The Applicant met with the ANC at executive sessions and presented at the full Commission meetings on April 23 & May 21. The representative for T-Mobile will work with the ANC to help match Ward 7 residents with employment opportunities at local T-Mobile storefronts and Ward 7 business owners with contract opportunities in connection with the construction of the proposed facility. At the meeting on May 21, Network Building & Consulting arranged for Matt Butcher of Sublight Engineering PLLC to be in attendance to provide expert explanation of radio frequency technology in response to both concerns of the Commission and community members' questions.
