Application of 1128 6th Street LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle C § 1504 from the penthouse setback requirements of Subtitle C § 1502.1, and under Subtitle F § 5201 from the lot occupancy requirements of F § 304.1 to construct a three-story addition, a rear penthouse addition, and to convert a principal dwelling into a six-unit apartment building in the RA-2 Zone at premises 1128 Sixth Street N.W. WHY YOU ARE RECEIVING THIS NOTICE
