Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on Wednesday, July 31, 2019 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Christina Fisher, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E §§ 205.5 and 5201, from the rear yard requirements of Subtitle E § 205.4, the lot occupancy requirements of Subtitle E § 304.1, and the non-conforming structure requirements of Subtitle C § 202.2, to construct a two-story, rear addition, and to convert an existing attached principal dwelling into a flat in the RF-1 Zone at premises 530 11th Street, S.E. (Square 994, Lot 816).

## WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

## HOW TO FAMILIARIZE YOURSELF WITH THE CASE

In order to review exhibits in the case, follow these steps:

## HOW TO PARTICIPATE IN THE CASE

Applications for Party Status must be filled with the Board <u>14 DAYS PRIOR</u> to the scheduled hearing date.

The ANC in which the property is located has also been notified and is considered an automatic party to the case. The Board expects the ANC to review the case and submit a written report of its position on the Application prior to the BZA hearing.
