An individual, organization, or ANC is alleging an error in the determination or decision made by an administrative officer in the administration or enforcement of the Zoning Regulations of the District of Columbia (Regulations) regarding property within your ANC's boundaries. This appeal was filed on March 15, 2019 through the Interactive Zoning Information System (IZIS).

Appeal of Arboretum Neighborhood Association, pursuant to 11 DCMR Subtitle Y § 302, from the decision made on January 27, 2017 by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to issue an unpublished Zoning Certification in response to a request to certify that a community-based institutional facility (adult rehabilitation center) is a matter-of-right use in the PDR-1 Zone at premises 3400 New York Avenue N.E. (Parcel 173/118).

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and Board gives "great weight" to its written report.
