An Applicant within the boundaries of your ANC Single Member District is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on <u>April 25, 2019</u> through the Interactive Zoning Information System (IZIS).

(Square 933, Lot 47).
