An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on May 29, 2019 through the Interactive Zoning Information System (IZIS).

Application of Korey Marable, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle D §§ 306.4 and 5201 from the rear addition requirements of Subtitle D § 306.3, to construct a second story addition to an existing, semi-detached principal dwelling unit in the R-2 Zone at premises 4672 A Street S.E. (Square 5349, Lot 30).
