## **BZA Application No. 20095**

Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on Wednesday, September 18, 2019 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Mi Casa, Inc., pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the zone boundary line provisions of Subtitle A § 207.2, and pursuant to Subtitle X, Chapter 10, for variances from the loading requirements of Subtitle C § 901.1, and from the zone boundary line requirements of Subtitle A § 207.1, to raze the existing detached principal dwelling unit, subdivide eight lots, and to construct a mixed use building with 24 residential units, retail space and non-profit office space in the MU-4 and RF-1 Zones at premises 14 Florida Avenue N.W. (Square 615, Lots 75, 148, 149, 150, 151, 152, 806, and 825).

# WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
