Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, September 18, 2019 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Alabama Apartments LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the new residential development provisions of Subtitle U § 421, to construct 86-unit affordable housing units in a new three-story building with 14 surface parking spaces in the RA-1 Zone at premises 2483-2491 Alabama Avenue, S.E. (Square 5730, Lots 7, 9, 11, 118-126, 800, 801, 861, 863, 865, 867, 869, 871, 918).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

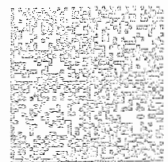
