REFERRAL MEMORANDUM AND NOTICE OF PUBLIC HEARING

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on June 14, 2019 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on Wednesday, October 9, 2019 at 9:30 am, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Darius Arod, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exception under Subtitle D § 5201 from the side yard requirements of Subtitle D 206.2, and the rear yard requirements of Subtitle D § 306.2, to construct a rear deck addition and a rear porch addition in the R-3 Zone at premises 1440 T Street S.E. (Square 5605, Lot 835).
