The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for <u>Wednesday</u>, <u>November 6</u>, <u>2019 beginning at 9:30 a.m.</u>, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001:

Application of Joyce Cowan, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under the use permissions of Subtitle U § 301.1(g) and under Subtitle E § 5201 from the lot occupancy requirements of Subtitle E § 404.1, from the accessory building lot occupancy requirements of Subtitle E § 5003.1, from the accessory building rear yard setback requirements of Subtitle E § 5004.1, and from the nonconforming structures requirements of Subtitle C § 202.2, to construct a second-story addition to an existing accessory structure to be used as a studio, garage and second-floor dwelling unit in the RF-2 Zone at premises 1436 S Street N.W. (Square 207, Lot 49).

- **B.** Attend the hearing and provide oral testimony as a "person in support" or "person in opposition" at the hearing.
- **C. Apply for Party Status** for more in depth involvement in the case.
 - Upload a Party Status application (Form 140) to the case record in IZIS or send to bzasubmissions@dc.gov
 - Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the <u>originally</u> scheduled hearing date set forth in this letter.
