The Board of Zoning Adjustment (Board or BZA) will consider the following application during the public hearing session scheduled for <u>Wednesday</u>, <u>January 29</u>, <u>2020 beginning at 9:30 a.m.</u>, in the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001:

Application of Murat Kayali, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under the penthouse requirements of Subtitles C § 1504.1 from the setback requirements of Subtitle C § 1502.1 (a), C § 1502.1 (b), and C § 1502.1 (c)(1)(A), and pursuant to Subtitle X, Chapter 10, for a variance from the maximum lot occupancy requirements of Subtitle F § 604.1, to construct a rear deck addition and an accessory structure in the RA-8 Zone at premises 1738 Church Street N.W. (Square 156, Lot 313).

 - Electronic submissions sent after 9:00 A.M. on the morning of the hearing will not be accepted into the record. Hard copy documents may be submitted to the case record by delivering in person at the time of the hearing when the case has been called by the Secretary.
- **B.** Attend the hearing and provide oral testimony as a "person in support" or "person in opposition" at the hearing.
- C. Apply for Party Status for more in depth involvement in the case.
 - Upload a Party Status application (Form 140) to the case record in IZIS or send to bzasubmissions@dc.gov
 - Applications for Party Status **must be filed with the Board 14 DAYS PRIOR** to the <u>originally</u> scheduled hearing date set forth in this letter.
