

TESTIMONY AT BZA APPEAL #20191  
AUG 5 2020

Dear Commissioners:

I support the appeal in BZA Case No. 20191.

My unique interest in this important historic site match those along with the Appellants which means it is paramount the law be followed pertaining to zoning as well as to preservation. The Zoning Administrator has not followed the law.

All existing historic preservation covenants that run with the site in perpetuity should be included in the land covenants that are required to be recorded according to the zoning regulations. The Zoning Administrator failed to ensure this.

Moreover, the McMillan Master Plan requires another look by the Zoning Commission in a Second-Stage Planned Unit Development review before any demolition can begin. This is clear in their first Zoning Order No. 13-14(6). The Zoning Administrator didn't ensure the Zoning Commission saw the plans under Second-Stage review or waive those requirements per the law.

The law is clear and the Permits were issued prematurely. Please affirm the appeal.

As a person with keen interest in the site, the historic McMillan Park and currently proposed redevelopment plans are . . .

The McMillian Park is one of the reasons my Mom and Dad brought our home on North Capitol Street NW 52 years ago. The drastic change is heartbreaking and devastating.
